JOB SUMMARY:

Conducts investigations and provides support for the trial of criminal cases. Provides evaluation and analysis of the investigative work completed by law enforcement agencies. Performs other duties as directed by the District Attorney or the Chief Investigator.

General Duties:

Works closely with the prosecutor responsible for prosecuting violent crimes against women. Reviews criminal cases as assigned. Assists in court during regular scheduled dockets. Locates and interviews victims, witnesses, and other persons deemed to be relevant to the case.

Case Intake and review.

Assists in the presentation and preparation of courtroom/trial material.

Testifies in court when necessary.

Assists local law enforcement agencies with criminal investigation as required.

Serves citations and subpoenas as required.

Assists in preparation and execution of arrest and search warrants.

REQUIREMENTS:

High school diploma/GED; currently Licensed as a Texas Peace Officer, Advanced TCOLE Certification preferred but not required. Eight (8) years law enforcement experience, with a minimum of Five (5) years of investigative experience is a must. Must possess or be willing to obtain a TCOLE instructors license. Spanish speaker preferred, but not required. Good computer skills; working knowledge of spreadsheet, word processing and database software; good verbal and written communication and organizational skills; interpersonal skills and ability to deal effectively with the public and victims of crime and their families. Must be able to complete projects and tasks in a in a timely and accurate manner. Knowledge of TCIC/NCIC databases.
