You may request a **Driving Safety Course**, however you will lose that right if you do not provide written notice to the court on or before the Appearance Date on your Citation. **READ INSTRUCTIONS CAREFULLY - FAILURE TO DO SO MAY VOID YOUR REQUEST.** Under the Code of Criminal Procedure Art. 45.0511, the Court shall defer proceedings and allow you 90 days to present evidence that subsequent to the alleged offense, you have successfully completed a DRIVING SAFETY COURSE approved by the Texas Dept. of Public Safety IF:

- (1) You request to take the course **on or before the appearance date on the citation** and the request is sent by certified mail;
- (2) You pay with a **MONEY ORDER OR CASHIERS CHECK** for **\$144.00** made payable to the court;
- (3) You submit copy of **Financial Responsibility (Insurance) AT THE TIME DRIVING SAFETY IS REQUESTED;**
- (4) You have **NOT** taken a similar course to have a citation dismissed in the preceding 12 months and are not taking one for another violation at the present time, and sign the Affidavit: DRIVING SAFETY COURSE REQUEST AND AFFIDAVIT
- (5) The offense charged was not **speeding 25 mph or more over the speed limit**, and
- (6) Submit a copy of a valid Texas driver's license or permit, **DRIVERS WHO HOLD A C.D.L. ARE NOT ELIGIBLE;**
- (7) You plead **GUILTY OR NOLO CONTENDERE** to the charge, and
- (8) You must provide a Driving History Record from the Texas Department of Public Safety (forms are available at the Justice Courts). **DO NOT TAKE DRIVING SAFETY COURSE PRIOR TO COURT APPROVAL**

Upon Completion you will receive a CERTIFICATE OF COMPLETION from the agency where you took your course. You MUST sign the original COURT COPY and submit to the Court along with the DRIVING RECORD so that credit can be given and the charge dismissed.

**DRIVING SAFETY COURSE REQUEST AND AFFIDAVIT**
