ORDER REGULATING HUNTING WITH BOW AND ARROW ON COUNTY SUBDIVISION LOTS 10 ACRES OR SMALLER

WHEREAS, the Commissioners Court of Medina County, Texas desires to promote public safety and reduce the danger to the public caused by hunting with bows and arrows on certain subdivision tracts; and

WHEREAS, Section 235.042 of the Texas Local Government Code authorizes the Commissioners Court of a county, by order, to regulate hunting with bows and arrows on lots that are ten (10) acres or smaller and are located in subdivisions which have been platted and filed of record, and are located, all or part, in the unincorporated area of the county.

NOW, THEREFORE, the Medina County Commissioners Court enters the following order in multiple parts as follows:

Section 1 – Definitions and Parameters

- 1.1 **"Hunt"** means capture, trap, take, kill, or an attempt to capture, trap, take, or kill. See Texas Parks and Wildlife Code §1.101(1), as amended.
- 1.2 **"Bow"** means a weapon for shooting a projectile, including, but not limited to, an arrow, typically made of a curved piece of wood whose ends are joined by a taut string.
- 1.3 **"Arrow"** means a projectile with a shaft sharpened at the font, often in the shape of an arrow.
- 1.4 **"Subdivision"** means a subdivision of real property, all or part of which is located in the unincorporated area of a county, and for which a plat is required to be prepared and filed under Chapter 232, Texas Local Government Code, as amended.

Section 2 – Bowhunting Prohibited

To promote the public safety, a person may not hunt any animal with bows and arrows on lots that are ten (10) acres or smaller and are located in a Subdivision in the unincorporated area of Medina County. If a subdivision is partly located within a municipality, the prohibition provided herein shall apply only to that portion of the subdivision which is outside the incorporated limits of said municipality. See TEX. LOC. GOV'T CODE §235.042.

Section 3 – Criminal Penalty

Pursuant to Texas Local Government Code §235.045, a person commits an offense if the person intentionally or knowingly engages in conduct that is in violation of a regulation under this Order. An offense under this section is a Class C misdemeanor. If it is shown on the trial of an offense under this Order that the person has previously been convicted of an offense under this section, the offense is a Class B misdemeanor.

Section 4 – Effect on State Law

These regulations do not legalize anything prohibited under the Penal Code or other state law. These regulations do not limit any defense found in the Penal Code or other state law.

Section 5 – Injunctive Relief


Any person is entitled to appropriate injunctive relief to prevent a violation or threatened violation of this ordinance from continuing from occurring. See TEX. LOC. GOV'T CODE §235.044.

Section 6 – Repealer and Effective Date


