

NOTICE OF ELECTION

TO THE RESIDENT, QUALIFIED VOTERS OF THE MEDINA VALLEY INDEPENDENT SCHOOL DISTRICT

TAKE NOTICE that an election will be held in the Medina Valley Independent School District on May 6, 2023 concerning the issuance of bonds in accordance with an order that reads substantially as follows:

AN ORDER CALLING A BOND ELECTION TO BE HELD BY THE MEDINA VALLEY INDEPENDENT SCHOOL DISTRICT, MAKING PROVISION FOR THE CONDUCT OF A JOINT ELECTION, AND RESOLVING OTHER MATTERS RELATED TO SUCH ELECTION

WHEREAS, the Board of Trustees (the *Board*) of the MEDINA VALLEY INDEPENDENT SCHOOL DISTRICT (the *District*), located in Medina and Bexar Counties, Texas (individually, the *County*, collectively, the *Counties*), hereby finds and determines that an election should be held to determine whether the District shall be authorized to issue bonds of the District in the amount and for the purposes hereinafter identified (the *Election*); and

WHEREAS, concurrently with the Election, the District is conducting an election for certain Board trustee positions; and

WHEREAS, the Texas Education Code requires that an election for trustees positions, along with any other District election held concurrently therewith, be conducted jointly with a municipality including territory of the District on Election Day (defined herein); and

WHEREAS, the District anticipates conducting its Board election and the Election jointly with the City of Castroville, Texas (the *City*), which is a municipality within the District, on Election Day only (unless the City cancels its election); and

WHEREAS, the District will contract with the elections administrator of Medina County and the elections administrator of Bexar County (individually, the *Administrator*; together, the *Administrators*) to conduct all aspects of the Election; and

WHEREAS, the Election will be conducted by each County and held jointly with other political subdivisions for which each County is also conducting their elections (collectively, the *Participants*), as provided pursuant to an election services agreement and/or a joint election or similar agreement between or among (as applicable) the District, each County, and/or any Participants, entered into according to the Texas Election Code, as amended (the *Code*); and

WHEREAS, the Board hereby finds and determines that the necessity to construct various capital improvements within the District dictates that it is in the public interest to call and hold the Election at the earliest possible date to authorize the issuance of bonds for the purposes hereinafter identified; and

WHEREAS, the Board hereby finds and determines that the anticipated capital improvements identified in Measure A and corresponding Proposition A may be submitted to the qualified voters of the District as a single measure and corresponding proposition pursuant to

Section 45.003(g) of the Texas Education Code because these capital improvements will be predominantly used for educational and administrative purposes, none of which are the type of facilities described in Section 45.003(g)(1-6); and

WHEREAS, the Board hereby finds and determines that the actions hereinbefore described are in the best interests of the residents of the District; now, therefore,

BE IT ORDERED BY THE BOARD OF TRUSTEES OF THE MEDINA VALLEY INDEPENDENT SCHOOL DISTRICT THAT:

SECTION 1. The Election shall be held in the MEDINA VALLEY INDEPENDENT SCHOOL DISTRICT on May 6, 2023 (*Election Day*), which is a uniform election date under the Code and is 78 or more days from the date of the adoption of this order (the *Order*), for the purpose of submitting the following measure to the qualified voters of the District:

MEASURE A

Shall the Board of Trustees of the Medina Valley Independent School District be authorized to issue and sell bonds of the District, in one or more series, in the aggregate principal amount of not more than \$376,000,000 for the purposes of designing, constructing, renovating, improving, upgrading, updating, modernizing, acquiring, and equipping school facilities (including safety and security, a new high school, a new ROTC/ag building at the existing high school, and traffic-flow improvements) and the purchase of necessary sites for school facilities, such bonds to mature serially or otherwise (not more than 40 years from their date) in accordance with law; any issue or series of such bonds to bear interest per annum at such rate or rates (fixed, floating, variable, or otherwise) as may be determined within the discretion of the Board of Trustees, provided that such rate or rates of interest shall not exceed the maximum rate per annum authorized by law at the time of the issuance of any issue or series of such bonds; and shall the Board of Trustees of the District be authorized to levy and pledge, and cause to be assessed and collected, annual ad valorem taxes on all taxable property in the District sufficient, without limit as to rate or amount, to pay the principal of and interest on the bonds?

SECTION 2. One or more District election precincts are hereby established for the purpose of holding the Election, and one or more polling places are hereby designated for holding the Election in the District election precincts as identified in Exhibit A to this Order (which is incorporated herein by reference for all purposes). In compliance with the Code, the Administrator will appoint Presiding Judges, Alternate Presiding Judges, Election Clerks, and all other election officials for the Election. The District's Superintendent of Schools, the President of the Board of Trustees, or their designees can correct, modify, or change the Exhibits to this Order based upon the final locations and times agreed upon by the District, the Administrator, and the Participants, if any and as applicable, to the extent permitted by applicable law.

A. To the extent required by the Code or other applicable law, the appointment of election officials at polling locations must include a person fluent in the Spanish language.

B. On Election Day, the polls shall be open as designated on Exhibit A.

C. The main early voting location is designated in Exhibit B to this Order (which is incorporated herein by reference for all purposes). The individual named as the Early Voting Clerk as designated in Exhibit B is hereby appointed as the Early Voting Clerk to conduct such early voting in the Election. The Early Voting Clerk shall appoint the Deputy Early Voting Clerks. The main early voting location shall remain open to permit early voting on the days and at the times as stated in Exhibit B. Early voting shall commence as provided on Exhibit B and continue through the date set forth on Exhibit B, all as provided by the Code.

Additionally, permanent and/or temporary branch offices for early voting by personal appearance may be established and maintained according to the Code. In the event such permanent and/or temporary branch locations are established, information regarding the locations, dates, and hours of operation for early voting at these offices will be identified in Exhibit B hereto.

Each Administrator is authorized to establish an Early Voting Ballot Board for their respective counties and to designate the Presiding Judge of such Early Voting Ballot Board. The Presiding Judges of the Early Voting Ballot Board shall appoint two or more additional members to constitute their respective Early Voting Ballot Board members and, if needed, the Signature Verification Committee members required to efficiently process the early voting ballots.

SECTION 3. Any legally permissible voting method may be used for early voting and Election Day voting by personal appearance, and when required by the Code, at least one accessible voting system per polling place will be provided. Certain early voting may be conducted by mail according to the Code.

SECTION 4. The Board authorizes each Administrator to utilize a Central Counting Station (the *Stations*) as provided by the Code. The Administrators, or designees thereof, are hereby appointed as the Manager of their respective Stations who will establish a written plan for the orderly operation of the Stations according to the Code. The Board authorizes the Administrators, or the designees thereof, to appoint the Presiding Judges, the Tabulation Supervisors, and the Programmers of their respective Stations and may appoint Station clerks as needed or desirable. The Administrators will publish (or cause to be published) notice and conduct testing on the automatic tabulation equipment relating to the Station and conduct instruction for the officials and clerks for their respective Stations according to the Code.

SECTION 5. The official ballot shall be prepared according to the Code so as to permit voters to vote “FOR” or “AGAINST” the aforesaid measure that shall appear on the ballot substantially as follows:

PROPOSITION A

THE ISSUANCE OF \$376,000,000 OF BONDS BY THE MEDINA VALLEY INDEPENDENT SCHOOL DISTRICT FOR SCHOOL FACILITIES AND LAND (INCLUDING SAFETY AND SECURITY, A NEW HIGH SCHOOL, A NEW ROTC/AG BUILDING AT THE EXISTING HIGH SCHOOL, AND TRAFFIC-FLOW IMPROVEMENTS) AND THE LEVYING OF A TAX IN PAYMENT THEREOF. THIS IS A PROPERTY TAX INCREASE.

SECTION 6. All resident, qualified voters of the District shall be permitted to vote at the Election, and on Election Day, such voters shall vote at the designated polling places. The Election shall be held and conducted according to the Code and other applicable law. To the extent required

by law, materials and proceedings relating to the Election shall be printed in both English and Spanish.

SECTION 7. Notice of election, including a Spanish translation thereof, shall be published at least one time in a newspaper of general circulation in the District, with such publication occurring not more than 30 days and not less than 10 days before Election Day. Moreover, a substantial copy of this Order and the voter information attached to and incorporated herein for all purposes, including a Spanish translation thereof, shall be posted (a) not less than 21 days prior to Election Day (1) on the bulletin board used for posting notices of Board meetings, (2) in three additional public places within the District's boundaries, (3) in a prominent location on the District's internet website, and (b) in a prominent location at each polling place on Election Day and during early voting. A sample ballot shall be posted on the District's internet website not less than 21 days prior to Election Day.

SECTION 8. As of the date of this order, the District had outstanding an aggregate principal amount of debt equal to \$198,907,932 (including maintenance tax debt, if any); the aggregate amount of the interest owed on such District debt obligations, through respective maturity, totaled \$130,801,318; and the District levied an ad valorem debt service tax rate for its outstanding debt obligations of \$0.47219 per \$100 of taxable assessed valuation. Based on the bond market conditions on the date of the Board's adoption of this Order, the estimated maximum interest rate for any series of bonds authorized at the Election is 5.75% (expressed as a net effective interest rate applicable to any such series of bonds). The bonds that are the subject of this Election shall mature serially or otherwise over a specified number of years (but not more than 40 years from their date), as prescribed by applicable Texas law, though the District estimates that, based on current bond market conditions, such bonds will amortize over a 30-year period from their respective date of issue. The foregoing estimated maximum net effective interest rate and amortization period are only estimates, provided for Texas statutory compliance; they do not serve as a cap on the per annum interest rate at which any series of bonds authorized at the Election may be sold, or the amortization period for bonds that are the subject of this Election.

SECTION 9. The Board authorizes the District's President of the Board of Trustees, the Superintendent of Schools, or their designees to negotiate and enter into one or more joint election agreements, election services contracts, and/or similar contracts or agreements with the County, acting by and through the Administrator, and any Participants if desired or if required to comply with applicable law, as permitted and in accordance with the Code. In addition, the Board authorizes the President of the Board of Trustees, the Superintendent of Schools, or their designees to make such technical modifications to this Order that are necessary for compliance with applicable Texas or federal law or to carry out the intent of the Board, as evidenced herein.

SECTION 10. The recitals contained in the preamble hereof are hereby found to be true, and such recitals are hereby made a part of this Order for all purposes and are adopted as a part of the judgment and findings of the Board.

SECTION 11. All orders and resolutions, or parts thereof, which are in conflict or inconsistent with any provision of this Order are hereby repealed to the extent of such conflict, and the provisions of this Order shall be and remain controlling as to the matters ordered herein.

SECTION 12. This Order shall be construed and enforced in accordance with the laws of the State of Texas and the United States of America.

SECTION 13. It is officially found, determined, and declared that the meeting at which this Order is adopted was open to the public and public notice of the time, place, and subject matter of the public business to be considered at such meeting, including this Order, was given, all as required by Chapter 551, as amended, Texas Government Code.

SECTION 14. If any provision of this Order or the application thereof to any person or circumstance shall be held to be invalid, the remainder of this Order and the application of such provision to other persons and circumstances shall nevertheless be valid, and the Board hereby declares that this Order would have been enacted without such invalid provision.

SECTION 15. This Order shall be in force and effect from and after its final passage, and it is so ordered.

CONSIDERANDO QUE, el Distrito prevé llevar a cabo la elección de la Junta y la Elección conjuntamente con la Ciudad de Castroville, Texas (la *Ciudad*), que es un municipio dentro del Distrito, únicamente el Día de la Elección (a menos que la Ciudad cancele su elección); y

CONSIDERANDO QUE, el Distrito contratará al administrador de elecciones del Condado de Medina y al administrador de elecciones del Condado de Bexar (individualmente el *Administrador*, colectivamente los *Administradores*) para llevar a cabo todo lo concerniente a la Elección; y

CONSIDERANDO QUE, se celebrará la Elección en cada Condado y de forma conjunta con otras subdivisiones políticas para las cuales cada Condado también está llevando a cabo sus elecciones (de forma colectiva como las *Participantes*), según lo establecido de conformidad con un contrato de servicios electorales y/o un contrato de elección conjunta o similar entre (según sea el caso), el Distrito, cada Condado y/o cualquiera de las Participantes, celebrado de acuerdo con el Código Electoral de Texas según enmendado (el *Código*); y

CONSIDERANDO QUE, la Junta mediante la presente falla y determina que la necesidad de construir varias mejoras importantes dentro del Distrito dictamina que redundará en el beneficio

público convocar y celebrar la Elección a la mayor brevedad posible con el fin de autorizar la emisión de bonos para los fines identificados en el presente documento; y

CONSIDERANDO QUE, la Junta por la presente falla y determina que las mejoras importantes anticipadas e identificadas en la Medida A y la Propuesta A correspondiente pueden someterse a los votantes calificados del Distrito como una medida única y la propuesta correspondiente de acuerdo con la Sección 45.003(g) del Código Educativo de Texas, ya que estas mejoras significativas se utilizarán principalmente con fines educativos y administrativos, ninguna de las cuales son del tipo de las instalaciones descritas en la Sección 45.003(g)(1-6); y

CONSIDERANDO QUE, la Junta por la presente falla y determina que las acciones descritas anteriormente redundan en beneficio de los intereses primordiales de los residentes del Distrito; por lo tanto,

ORDÉNESE POR PARTE DE LA JUNTA DE SÍNDICOS DEL DISTRITO ESCOLAR INDEPENDIENTE DE MEDINA VALLEY QUE:

SECCIÓN 1. Se llevará a cabo la Elección en el DISTRITO ESCOLAR INDEPENDIENTE DE MEDINA VALLEY el día 6 de mayo de 2023 (*Día de la Elección*), que es una fecha uniforme de elección bajo el Código y está a 78 días o más de la fecha de la adopción de esta orden (la *Orden*), con el propósito de someter la siguiente medida a los votantes calificados del Distrito:

MEDIDA A

¿Deberá la Junta de Síndicos del Distrito Escolar Independiente de Medina Valley recibir la autorización para emitir y vender bonos del Distrito, en una o más series, por un monto de capital total no mayor a \$376,000,000 con el fin de diseñar, construir, renovar, mejorar, actualizar, modernizar, adquirir y equipar instalaciones escolares (incluyendo la seguridad y protección, una escuela secundaria nueva, un nuevo edificio para ROTC/ag en la escuela secundaria existente y mejoras en el flujo de tránsito) y la compra de los predios necesarios para las instalaciones escolares, tales bonos vencerán en serie o de otra manera (a no más de 40 años de su fecha) de acuerdo con la ley; cualquier emisión o serie de dichos bonos devengará un interés anual a una tasa o tasas (fija, flotante, variable o similar) según sea determinado a discreción de la Junta de Síndicos, siempre que dicha tasa o tasas de interés no excedan la tasa máxima anual autorizada por la ley en el momento de la emisión de cualquier emisión o serie de dichos bonos; y deberá autorizarse a la Junta de Síndicos del Distrito para imponer y comprometer, y hacer que se calculen y recauden impuestos anuales ad valorem sobre toda propiedad gravable en el Distrito de manera suficiente, sin límite en cuanto a la tasa o cantidad, para pagar el capital y los intereses sobre los bonos?

SECCIÓN 2. Mediante la presente se establecen uno o más precintos electorales del Distrito con el fin de celebrar la Elección, y uno o más lugares de votación son designados mediante la presente para la celebración de la Elección en los precintos electorales del Distrito según se identifica en el Anexo A de la presente Orden (que se incorpora aquí por referencia para todos los propósitos). De conformidad con el Código, el Administrador designará a los Jueces Titulares, a los Jueces Titulares Suplentes, a los Secretarios Electorales y a todos los demás

funcionarios electorales para la Elección. El Superintendente de Escuelas del Distrito, el Presidente de la Junta de Síndicos o las personas designadas podrán corregir, modificar o cambiar los Anexos de la presente Orden basados en los lugares y los horarios definitivos acordados por el Distrito, el Administrador y las Participantes, si hubiera y según sea aplicable, en la medida permitida por la ley aplicable.

A. En la medida requerida por el Código o cualquier otra ley aplicable, el nombramiento de estos funcionarios electorales en los lugares de votación debe incluir una persona que domine el idioma español.

B. El Día de la Elección, las urnas electorales deberán abrirse según lo señalado en el Anexo A.

C. El lugar principal de la votación anticipada es designado en el Anexo B de la presente Orden (que se incorpora aquí por referencia para todos los efectos). La persona nombrada como el Secretario de Votación Anticipada según lo señalado en el Anexo B, es por la presente designada como el Secretario de Votación Anticipada para llevar a cabo dicha votación anticipada en la Elección. El Secretario de Votación Anticipada deberá designar a los Suplentes de los Secretarios de Votación Anticipada. El lugar principal de la votación anticipada deberá permanecer abierto para permitir la votación anticipada en los días y horarios establecidos en el Anexo B. La votación anticipada deberá comenzar según lo estipulado en el Anexo B y continuará hasta la fecha establecida en el mismo, todo lo anterior según lo dispuesto por el Código.

Además, pueden establecerse y mantenerse oficinas secundarias permanentes y/o temporales para la votación anticipada en persona de conformidad con el Código. En el caso de que se establezcan dichos lugares secundarios permanentes y/o temporales, la información sobre los lugares, las fechas y los horarios de operación para la votación anticipada en estas oficinas estará identificada en el Anexo B de la presente.

Cada Administrador está autorizado a establecer una Junta de Boletas de Votación Anticipada para sus respectivos condados y a designar al Juez Titular de la Junta de Boletas de Votación Anticipada. Los Jueces Titulares de las Juntas de Boletas de Votación Anticipada nombrarán a dos o más miembros adicionales para formar parte de los miembros de su respectiva Junta de Boletas de Votación Anticipada y, si fuera necesario, de los miembros del Comité de Verificación de Firmas requeridos para procesar eficientemente las boletas de votación anticipada.

SECCIÓN 3. Se puede utilizar cualquier método de votación legalmente permitido para la votación anticipada y la votación en persona el Día de la Elección y, cuando lo requiera el Código, se proporcionará al menos un sistema de votación accesible por lugar de votación. Se puede realizar cierta votación anticipada por correo de acuerdo con el Código.

SECCIÓN 4. La Junta autoriza a cada Administrador para utilizar una Estación Central de Escrutinio (la *Estación*) según lo estipulado por el Código. Los Administradores, o las personas designadas, son nombrados mediante la presente como Gerentes de sus Estaciones respectivas, quienes establecerán un plan escrito para la operación ordenada de las Estaciones de conformidad con el Código. La Junta autoriza a los Administradores o a las personas designadas, para nombrar a los Jueces Titulares, a los Supervisores de Cómputo y a los Programadores de sus Estaciones respectivas y pueden nombrar secretarios de las Estaciones según sea necesario o deseable. Los Administradores publicarán (o harán que se publique) un aviso y realizarán las pruebas en el

equipo de cómputo automático relacionado con la Estación y darán las instrucciones para los funcionarios y secretarios de sus Estaciones respectivas, según lo dispuesto por el Código.

SECCIÓN 5: Se elaborará la boleta oficial de conformidad con el Código, a fin de permitir que los votantes voten "A FAVOR" o "EN CONTRA" de la medida antes mencionada, que aparecerá en la boleta substancialmente de la siguiente manera:

PROPUESTA A

LA EMISIÓN DE \$376,000,000 EN BONOS POR PARTE DEL DISTRITO ESCOLAR INDEPENDIENTE DE MEDINA VALLEY PARA INSTALACIONES ESCOLARES Y PREDIOS (INCLUYENDO LA SEGURIDAD Y PROTECCIÓN, UNA ESCUELA SECUNDARIA NUEVA, UN NUEVO EDIFICIO PARA ROTC/AG EN LA ESCUELA SECUNDARIA EXISTENTE Y MEJORAS EN EL FLUJO DE TRÁNSITO) Y LA IMPOSICIÓN DE UN IMPUESTO PARA EL PAGO DE LO ANTERIOR. ESTE ES UN INCREMENTO DEL IMPUESTO A LA PROPIEDAD.

SECCIÓN 6. Se les permitirá a todos los votantes calificados residentes del Distrito votar en la Elección, y el Día de la Elección, dichos votantes deberán votar en los lugares de votación designados. Se deberá realizar y llevar a cabo la Elección de conformidad con el Código y cualquier otra ley aplicable. En la medida requerida por la ley, los materiales y procedimientos relativos a la Elección deberán ser impresos en inglés y en español.

SECCIÓN 7. El presente aviso de elección, incluyendo una traducción al español del mismo, será publicado al menos una vez en un periódico de circulación general en el Distrito, y dicha publicación deberá realizarse en un plazo no mayor a 30 días y no menor a 10 días antes del Día de la Elección. Además, una copia fiel de esta Orden y la información para los votantes adjunta e incorporada a la presente para todos los fines, incluyendo una traducción al español de las mismas, deberán publicarse (a) a más tardar 21 días antes del Día de la Elección (1) en el tablero de anuncios utilizado para la publicación de avisos de las reuniones de la Junta, (2) en tres lugares públicos adicionales dentro de los límites del Distrito, (3) en un lugar visible en el sitio web de internet del Distrito, y (b) en un lugar visible en cada sitio de votación el Día de la Elección y durante la votación anticipada. Se publicará una boleta de muestra en el sitio web de Internet del Distrito a más tardar 21 días antes del Día de la Elección.

SECCIÓN 8. A partir de la fecha de esta Orden, el Distrito tenía pendiente un monto de capital total de deuda igual a \$198,907,932 (incluyendo deuda de impuesto por mantenimiento, si lo hubiere); el monto total de los intereses adeudados en dichas obligaciones de deuda del Distrito, al vencimiento respectivo, ascendía a \$130,801,318; y el Distrito recaudaba una tasa impositiva de servicio de deuda ad valorem para sus obligaciones de deuda pendientes de \$0.47219 por cada \$100 de la valuación tasada gravable. Con base en las condiciones del mercado de bonos en la fecha de adopción de la presente Orden por parte de la Junta, la tasa de interés máxima estimada para cualquier serie de bonos autorizados en la Elección es del 5.75% (expresado como una tasa de interés efectiva neta aplicable a cualquiera de dichas series de bonos). Los bonos que son objeto de esta Elección deberán vencer de forma serial o de otra manera durante un número determinado de años (pero a no más de 40 años de su fecha), según lo prescrito por la ley aplicable de Texas, aunque el Distrito estima que, con base en las condiciones actuales del mercado de bonos, se amortizarán dichos bonos durante un período de 30 años desde su fecha de emisión respectiva. La

tasa de interés efectiva neta máxima estimada anterior y el período de amortización son sólo estimaciones, proporcionados para el cumplimiento estatutario de Texas, y no sirven como un límite a cualquier tasa de interés anual a la cual se pueda vender cualquier serie de bonos autorizados en la Elección, o el período de amortización de los bonos que son objeto de esta Elección.

SECCIÓN 9: La Junta autoriza al Presidente de la Junta de Síndicos del Distrito, al Superintendente de Escuelas, o a las personas designadas, para negociar y celebrar uno o más contratos de elección conjunta, contratos de servicios electorales y/o contratos o acuerdos similares con el Condado, actuando por y a través del Administrador, y cualquiera de las Participantes si se desea o si se requiere para cumplir con la legislación aplicable, según lo permitido y de conformidad con el Código. Además, la Junta autoriza al Presidente de la Junta de Síndicos, al Superintendente de Escuelas, o a las personas designadas para efectuar las modificaciones técnicas que sean necesarias a esta Orden para cumplir con las leyes aplicables de Texas o federales o para llevar a cabo el propósito de la Junta, según se evidencia en el presente documento.

SECCIÓN 10. Los considerandos contenidos en el preámbulo del presente documento son verídicos, y dichos considerandos mediante el presente se hacen parte de la presente Orden para todos los efectos y son adoptados como parte de la sentencia y conclusiones de la Junta.

SECCIÓN 11. Todas las órdenes y resoluciones, o partes de las mismas, que entren en conflicto o sean inconsistentes con cualquier disposición de la presente Orden quedan derogadas por la presente, en la medida de dicho conflicto, y las disposiciones de la presente Orden deberán ser y permanecer vigentes con respecto a los asuntos ordenados en el presente documento.

SECCIÓN 12. La presente Orden será interpretada y aplicada de acuerdo con las leyes del Estado de Texas y de los Estados Unidos de América.

SECCIÓN 13. Se falla, determina y declara oficialmente que la reunión en la que se adoptó esta Orden estuvo abierta al público y se proporcionó el aviso público de la hora, lugar y objeto del asunto público a considerarse en dicha reunión, incluyendo la presente Orden, según los requerimientos del Capítulo 551, según enmendado, del Código Gubernamental de Texas.

SECCIÓN 14. Si alguna disposición de esta Orden o su aplicación a cualquier persona o circunstancia fuere considerada inválida, el resto de la presente Orden y la aplicación de dicha disposición a otras personas y circunstancias serán válidas, y la Junta mediante la presente declara que esta Orden habría sido aprobada sin dicha disposición inválida.

SECCIÓN 15. Esta Orden entrará en efecto y vigor desde y después de su aprobación final, y será así ordenada.
