

### NOTICE OF FORECLOSURE SALE

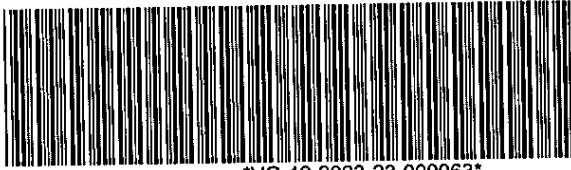

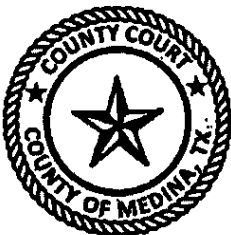
